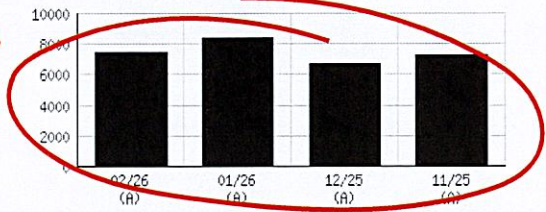

**How is my bill calculated?**

MMA Water:  $\$6.23/1,000$  gallons usage =  $\$6.23 \times 2 = \$12.46$

MMA Sewage:  $\$5.21/1,000$  gallons usage =  $\$5.21 \times 2 = \$10.42$

ALCOSAN Sewage:  $\$12.76/1,000$  gallons usage =  $\$12.76 \times 2 = \$25.52$
